Dear Parents of Private and Parochial School Students:

It is the policy of the Cheektowaga Central School District to offer transportation to district residents who attend Private and Parochial Schools, as long as the distance does not exceed fifteen miles. Depending on the particular bus route, students are expected to walk a moderate distance, usually less than one-half mile, to and from a bus stop. Therefore, a house stop should not be expected.

To comply with New York State law, you must request transportation by submitting the form below to the Cheektowaga Central School District Business Office **NO LATER THAN APRIL 1, 2016.**

**Requests received AFTER April 1 are subject to denial. Transportation requests must be renewed each year.**
