TUITION AND FEE INFORMATION FOR 2018-2019

*** FULL COST TUITION: This is the tuition for non-Catholic families and families that belong to a parish (other than Ss. Peter and Paul) that operates a school.**

**** ACTIVE PARISHIONER DISCOUNTED TUITION: This is the tuition for families who are registered at Saints Peter and Paul Parish and families from other parishes that do not operate a school.**

In order to receive the Active Parishioner Discounted Tuition, your family must be an active member of your parish, regularly attending Sunday Mass and sharing your time, talent and treasure. (See attached blue “Application for Active Parishioner Discount” for families of SSPP or the yellow “Tuition Grant Program CTGP” for families from parishes that do not operate a school.)

Families from Saints Peter and Paul Parish **MUST** be approved annually by Rev. Jerome Kopec. The attached blue “Application for Active Parishioner Discount ” form **MUST be signed by the parents** and returned with the registration/re-registration paperwork.

Families from other parishes must be approved **annually by their pastor** for tuition subsidy from their parish or the Diocese of Buffalo. The attached yellow “Tuition Grant Program CTGP” form **MUST BE SIGNED BY THE PARENTS AND YOUR PASTOR** and returned with the registration/re-registration paperwork.

KEY FACTS:

- New student registration fee of \$100 per student is due at the time of registration. This fee is non-fundable.
- Book fee is \$100 per child.
- Technology/Activity fee is \$40 per child.
- BOCES fee is \$40 per child
- 8th Grade fee is \$100 per child.
- Home School Association (HSA) fee is \$10 per family.
- Re-registration deposit is \$100 **per family**, due by **Feb. 2, 2018**. **This fee is non-refundable and will be deducted from the total tuition due.**
- Each family is required to sell \$200 worth of sweepstakes tickets per school year.
- Our school uses the FACTS Management Company to collect tuition. The ACH payment option will transfer funds from either a checking or savings account. There are no exceptions. All families must complete the FACTS Automatic Tuition Payment Agreement online at the time of registration/re-registration, unless payment is made in full. The FACTS payment plan can be accessed right from our school’s website. Families currently enrolled in FACTS will be electronically re-enrolled for the next school year. Questions regarding FACTS enrollment, tuition or fees should be directed to Shirley Sutton at 632-6146.
- Families who do not choose to use FACTS Management Company **MUST** pay the full tuition and fees by **Aug. 31, 2018**. There is a \$100 discount if you pay in full by that date.
- All registered families must return the signed Tuition Payment Form indicating the amount of tuition owed and the payment option chosen. This form must be signed by **BOTH** parents.
- Financial Aid is available through the BISON Fund. These forms may be obtained on the school website or by contacting the school office at 632-6146.
